9.1 Fly tipping problems

Numerous fly tipping over recent weeks, all reported, Clerk confirmed an email to all residents was sent encouraging the reporting via website portals.

Members decided to consider further action, including CCTV – Costs and options to be reported to Feb 2023 meeting. Members were very concerned about the escalation of these issues.

Further posts on social media to continue to encourage residents to report all fly tipping.

County Cllr and district Cllrs were aware of the problems and confirmed this was happening in many areas across the district.

Clerk to contact other local parishes to see if able to collaborate to encourage the councils to take more action against the fly tippers. It was confirmed that the evidence collected from the fly tipping sites which could have been used to prosecute had not appeared to been followed up by the County or District council.

9.2 Update regarding correspondence between Bishop of Southwark and PC – Clerk emailed again and received confirming that their position hasn't changed. (its has taken them 4 months to reply to the recorded delivery letter sent. The Bishop of Southwark office will be writing to to HPC formally to confirm this – Letter and further actions to be considered in February meeting. The parish council has been waiting for the church to provide a public meeting space since for over 4 years after the church sold the hall that was used by residents of Horne. Members asked for information about the hall sale and subsequent lack of public space in the parish to be shared in the next parish council Newsletter, to ensure that residents are aware of facts and the actions being taken by both parties.
