5.1	County Cllr : HGVs- will follow up with our MP as to the current position. We had a meeting with Lingfield residents where the same issues were raised Budget for Surrey is about to be finalised. The pending increase in SCC council tax will be either 3 or 5%. I have objected but was told the increase is to cover the spiralling costs of adult and child social care and SEND. Highways- due to restructuring we have lost our local Highways officers including Steve Cunnah who have been relocated elsewhere. placed that it is for the sole use of storage for hay/straw and not for the parking of commercial vehicles.
